ADJUSTED REQUIREMENTS DUE TO COVID-19 RELATED DISRUPTIONS

In the event the applicant is unable to meet the above listed patient experience and case volume requirements **due to COVID-19 related training disruptions**, they may satisfy the requirements through one of two alternative pathways listed below. In addition, the fellowship program director will complete the attached certification of fellowship requirement completion form which should be submitted along with all other supporting documentation.

Alternate Pathway #1: The total number of cases and patient encounters listed above will not be reduced. However, the applicant may contribute up to 25% of the encounter/case numbers in select categories from their experience as a senior resident or attending surgeon during the 2 years prior to fellowship (July 2018 through June 2020). A detailed case log verifying the listed case volumes must be submitted with the application. The fellowship Program Director must also sign below verifying that the applicant’s case volumes were disrupted due to COVID-19 related shutdowns or limitations on elective surgery.
