CBN Collaborated Symposium at 2021 Annual Meeting

The CBN encourages all CBNs to attend the symposium on "patient education", which will systematically explore this important aspect of bariatric surgical nursing.





Overview: The purpose of this symposium is to focus on issues and trends that occur during preoperative and pre-hospital discharge bariatric surgical patient education practices. This symposium will address four main topics: patient educational content and how it's determined, considerations related to dose, delivery, and patient access methods, the measurement of knowledge and effect on patient outcomes, and the effects of COVID-19 on patient education practices.

HOW DO I BECOME MORE INVOLVED IN CBN?

Practice Analysis UPDATE: Here we are again ...

There are 3 ways that you can become involved with the "practice analysis". In simple terms, it is the definition the of the *standard of practice* of bariatric/metabolic surgical nursing. Approximately, every 5 years it is necessary for all certifications to review and update as needed their "Practice Analysis", sometime called a "Job Analysis". The practice analysis includes the <u>performance domains</u> and <u>tasks</u> related to the purpose of the credential, and <u>knowledge and/or skills</u> associated with the performance domains and tasks and use them to develop specifications for the examination/assessment instruments. In this "update" situation, we will need to review the current practice analysis which included the domains of practice the tasks, skills, and knowledge needed to practice bariatric and metabolic surgical nursing. Specifically, the review will focus on the question, what has changed over the last 5 years in the practice of metabolic and bariatric surgical nursing? After the review takes place, working with our certification consultant, PSI, a survey will be developed and sent out to bariatric/metabolic surgical nurses all over the country to ask practitioners about job-related tasks; their frequency and importance in their daily work. Additionally, the survey questions will focus on the knowledge required as applied on the job.


The 3 ways you can become involved are:

- (1) You can volunteer to be on the CBN Practice Analysis subcommittee. This strategic planning group will actually be working with our certifications consultant to oversee the process.
- (2) You can volunteer to be on the Practice Analysis Task Force which will be assembled by the subcommittee (10-15 CBNs), representing nurses of differing geographic regions, practice environments, levels of bariatric/metabolic surgical nursing experience, and working in all surgical procedures. They will review and discuss the current state of bariatric/metabolic surgical nursing, review and update the survey, and then review the survey results and update the domains, tasks and knowledge statements that are the blueprint of the CBN examination.
- (3) You can complete the survey that will be sent out to you, so your practice perspective is included in updated practice analysis.

At this point, if options 1 or 2 appeal to you, please email the CBN manager at cbn@asmbs.org.

We anticipate this project to beginning in late summer/fall '21 and will take about 9 – 12 months. We hope to publish this practice analysis update in SOARD. Subcommittee and task force members will be eligible to be authors of the publication.
