CLINICAL ACTIVITIES

Clinical Focus

My clinical focus has been on providing outpatient treatment for adult and adolescent patients diagnosed with eating disorders and on presurgical psychological screening of patients seeking bariatric surgery. My expertise is in implementing Cognitive Behavioral Therapy and Motivational Enhancement Therapy for the treatment of disordered eating as well as comorbid anxiety, depression, and substance abuse. Recently, I have focused on developing outpatient meal-based interventions for patients with anorexia nervosa including Exposure and Response Prevention therapeutic techniques. Obsessive compulsive disorder is highly comorbid with anorexia nervosa and fear of weight is associated with avoidance of high-energy density foods and the use of safety and avoidance behaviors to limit calorie intake. Exposure and Response Prevention has shown preliminary efficacy in the treatment of patients with anorexia nervosa and is the gold standard treatment for obsessive compulsive disorder. Following a well-received workshop at the annual International Conference on Eating Disorders in June 2022, I have been developing a treatment manual focused on meal-based approaches for eating disorders including therapist-patient meals and coaching strategies to help patients with anorexia consume feared foods in appropriate portions and social settings. I also conduct a 1-day/week clinic providing pre-surgical psychiatric evaluations for individuals preparing to undergo metabolic and bariatric surgery (MBS) and provide individual cognitive behavioral therapy for preand post-surgical patients with eating disorders, anxiety, or depression. Th bariatric eating disorders clinic has a focus on managing binge eating pathology following MBS, as binge behavior can negatively impact postsurgical outcomes. I am frequently referred patients from within Johns Hopkins Medicine and from the local community. (MD/PA/DC).

RESEARCH ACTIVITIES

Research Focus

My clinical interests include examining predictors of short-term outcome following intensive treatment for anorexia nervosa and avoidant restrictive food intake disorder (ARFID). I have focused on the importance of achieving weight restoration and practicing normative eating behaviors, including consumption of high-calorie density foods as the strongest predictors of treatment outcome and am interested in developing strategies, to help prevent relapse in patients with anorexia nervosa during the high-risk period immediately following inpatient discharge and achievement of a healthy minimum weight. Specifically I am interested in the roles of food anxiety, learning, and decision making around food that influence food preferences and choice in eating disorders. A secondary clinical research interest focuses on examining psychosocial predictors of treatment outcomes for patients undergoing bariatric surgery, including the impact of disordered eating, depression, and pain catastrophizing.
