- The FASMBS-IH Review Taskforce's decision is final. If applicant is not awarded the FASMBS-IH designation, the applicant may reapply to the FASMBS-IH program when the service and leadership requirement(s) have been sufficiently documented.
- If your FASMBS-IH application was not approved during the 2023 application cycle, you may qualify for a 25% discount on the 2024 application fee. Please contact morgan@asmsb.org if this applies to you.
- The applicant has not been convicted or under prosecution for illegal activity or dismissed by an employer for illegal or unethical behavior.
