We want to take this opportunity to extend our deepest gratitude to Bill Gourash, who served as the CBN Chair for 20 years, and Jesse Moore, who has been a longstanding co-chair. Their dedication and long-term commitment to the CBN Committee and certification program have been instrumental in its success and growth. We are incredibly grateful for their leadership and the strong foundation they've built. What is the CBN certification?

The Certified Bariatric Nurse (CBN) certification is a professional credential for nurses specializing in the care of patients undergoing metabolic and bariatric surgery. The examination is designed to assess the professional competence of practitioners in the specialty of metabolic and bariatric nursing. It signifies a nurse's dedication, expertise, and commitment to providing high-quality care in the field of metabolic and bariatric nursing.

CBN Accreditation Status

ASMBS and the CBN Accreditation Council are actively pursing accreditation through the National Commission for Certifying Agencies (NCCA), a Magnet Recognition Program approved accreditation authority. The process is comprehensive and ongoing, with a dedicated team working towards meeting all necessary criteria for accreditation. While ASMBS is making significant progress and prioritizing this effort, a specific timeline for completion is not yet available. However, ASMBS is committed to keeping candidates informed and will share updates as soon as they become available. Why is accreditation of the CBN certification important?

Accreditation ensures that the CBN certification meets the highest standards of professional excellence and credibility. It is a mark of quality that reflects adherence to stringent criteria regarding the certification's development, administration, and governance.

How does Magnet designation relate to CBN certification?

Magnet-designated health systems and some other non-Magnet-designated hospital systems recognize and often financially support nurses in obtaining certifications that are accredited by the organizations recognized by the Magnet Recognition Program. Accreditation of the CBN certification would enable more nurses to obtain this credential with financial support from their employers, enhancing the quality of care provided to metabolic bariatric surgery patients.

What should I do if I'm interested in obtaining the CBN certification, but my hospital requires it to be accredited?

ASMBS is actively working towards achieving NCCA accreditation, and sharing this information may help in discussions about potential support for obtaining the CBN certification in the future.

The official review course for the Certified Bariatric Nurse (CBN) exam, a long-standing feature of the ASMBS Annual Meeting, has also found a home on a well-used online platform. Some pioneering CBNs have taken the initiative to include a review course in their state chapter's annual meeting, setting a commendable precedent for their peers!

Jamie J. Carr, BSN, RN, CBN, FASMBS-IH, has been an active CBN for nearly two decades and recognized an inherent need to expand course offerings to support and engage Texas nurses pursuing the credential. As a longstanding member of the Texas Association for Bariatric Surgery (TABS) and the former Integrated Health Section (IHS) president of the same, she was uniquely equipped to recognize the benefit that growing providers with specialized training in obesity and metabolic and bariatric care would have on her profession and the population we serve. She is passionate about providing clinically excellent and competent care for those battling obesity and has practiced in this field for over twenty-five years. Because many programs cannot send their teams to national conferences, Jamie set out to secure a means of ensuring the specialized knowledge and skills of the metabolic and bariatric nurse could be accessible to all nurses in her state. In so doing, she has elevated the profession and improved the quality and safety of metabolic and bariatric care for those choosing to treat their obesity with metabolic and bariatric surgery. Including a CBN review course in the TABS annual meeting has the additional benefit of increasing networking opportunities for like-minded nurses and facilitating collaboration across program lines. This again impacts access and knowledge while advancing care for this vulnerable population.

Recognizing the appropriate path to requesting the addition of a CBN review course to an annual state meeting can be daunting, especially if IH does not have an identified seat at the leadership table. However, in a recent survey sent to over three hundred program coordinators, over sixty percent of the respondents were unsure if IH was represented in their state leadership. Despite this, over seventy percent endorsed a desire to see a CBN review course offered at a state-level meeting. This data is encouraging and a sign of the potential impact the CBN review course can have on state-level meetings. When asked for advice, our seasoned pro, Jamie, suggested that, in addition to reaching out to the CBN Committee, the IH leader liaises with the state chapter's Executive Board to gain support and recruit a CBN planning committee. The TABS surgeons could be fantastic mentors for state leaders looking to navigate a path to incorporating IH into their numbers. They have recognized the value of the Texas IH members' unique insight and granted them the capacity to form sub-committees, program planning committees, and membership drives specific to IH. Jamie encourages those looking to grow their influence and refine their specialties to be encouraged and persevere. She also suggests considering applying to serve on one of the national ASMBS IH committees, as the experience and relationships gained in these endeavors are invaluable.

Jamie credits the ASMBS CBN Committee with helping to ensure that all guidelines integral to a comprehensive local review course are provided. The CBN Committee is eager to help make the integration process into state meetings a reality.

Featured Article

GLP-1s vs Metabolic and Bariatric Surgery by Shirley Bearden RN, CBN

There has been a lot of talk recently about the use of GLP-1 medications—from healthcare professionals, patients, family members, and even people in stores. We've heard people say they are diabetic and unable to obtain their medication because others are using it to lose weight. Articles discuss how pharmacies receive such low reimbursement for these medications that it may actually cost them to fill prescriptions, leading some to decline to do so. MBS coordinators have also noted a decrease in their metabolic and bariatric surgery volumes, attributing this decline to the increased use of GLP-1s.

As advocates for patient access to care, it is imperative that we consider the benefits of anti-obesity medications. At the ASMBS 2024 Annual Meeting, a study was presented indicating that pre-operative use of GLP-1s may reduce complications after metabolic and bariatric surgery in patients with a BMI greater than 70. Another study presented at the same meeting reinforced that metabolic and bariatric surgery is more effective and durable than new anti-obesity medications. However, GLP-1s did result in weight loss, and this was maintained as long as the medication was continued. One issue observed in my area is that physicians will prescribe GLP-1 medications for their patients but do not plan to continue appropriate therapy once the patient reaches their goal weight. Weight recurrence will occur if the medication is discontinued—a finding confirmed in another study presented at the ASMBS 2024 Annual Meeting.

In an article published in Yale Medicine on April 2, 2024, John Morton, MD, MPH, medical director of metabolic and bariatric surgery for the Yale New Haven Health System, stated that he found placing patients on GLP-1s prior to weight-loss surgery helped them achieve better results. He further explained that patients were taken off GLP-1s immediately after surgery, as their bodies needed to adjust physiologically.

Surgeons have also noted that adding GLP-1s for patients experiencing weight recurrence after MBS is beneficial in reproducing the weight loss initially achieved from surgery.

We are the advocates, the educators, the ones who continue to shed light on the disease of obesity. To anyone who thinks that people are using their lifesaving medication just to lose weight: losing weight is lifesaving. Whether through anti-obesity medications, metabolic and bariatric surgery (with the high cost of GLP-1s, some insurance companies have eased access to metabolic and bariatric surgery), or a multifaceted approach, all of these are valid paths that help navigate our patients back to a healthier life.
