To maintain our accreditation with the Accreditation Council for Continuing Medical Education (ACCME), it is essential that we adhere to all applicable guidelines and standards.

A key component of maintaining this accreditation is compliance with the **ACCME Standards for Integrity and Independence in Accreditation**, which govern the interactions between CME providers and commercial supporters. Please review the following to ensure you understand and meet these requirements:

Key Principles of ACCME Standards for Integrity and Independence

1. **Independence:** CME content must be free from commercial influence and determined by the provider, not by outside interests.
2. **Integrity:** Ensure transparency and disclose any relevant financial relationships of those involved in the CME activity to avoid conflicts of interest.
3. **Disclosure:** Faculty and planners must disclose any financial ties to commercial interests, and steps should be taken to manage conflicts.
4. **Balanced, Evidence-Based Content:** Provide information based on the best available evidence, ensuring a balanced, unbiased perspective.
5. **Evaluation:** Providers must monitor and assess CME activities for effectiveness and compliance with standards.
6. **Program Planning:** CME should be based on identified needs and undergo peer review for scientific accuracy.
7. **Accountability:** Providers must meet ACCME accreditation requirements, maintain records, and report on activities.
8. **Quality:** CME programs must uphold high standards of quality and maintain educational integrity, free from commercial bias.
